The Members desiring to contest Election for the vacant post of as arising out of retiring of senior Members in CoA are required to fill his/her Nomination in the "prescribed format", as attached and as available on Council's Website and ensure that it is submitted to the **Indian Silk Export Promotion Council's Registered Office at 112-A, First Floor, Chiranjiv Tower, 43 Nehru Place, New Delhi - 110019**, within the stipulated date i.e. **by Tuesday, the 8th September 2026**. The Members belonging to MSMEs ("He or she entity represented by him/her) desires to contest election, **must have to its credit, during the last two financial years (2024-25 & 2025-26)** immediately preceding the election, the average exports of the products falling under the purview of the Council of not less than the amount below:-

Micro Enterprises	Rs. 50 lakhs	Small Enterprises	Rs. 1 Crore
Medium Enterprises	Rs. 2.5 crores	Others	Rs. 2.5 Cores

For the purpose of determining whether an industry is a Micro, Small or Medium Enterprises, the MSME Certificate / Udyam Certificate issued by the Ministry of Micro Small and Medium Enterprises shall be conclusive. For Start-up, the certificate issued by the Department of Promotion and Industrial and Internal Trade (DPIIT) shall be conclusive.

The Candidate/Proposer/ Secunder must be an Ordinary Registered Member of the Council for at least one year; and submit the export performance of the member entity company, duly verified by the Chartered Accountant, as proof thereof. Forms No-I(a & b) -Nomination Form to be filled by Proposer & Secunder, Form No. IA- Acceptance Form to be filled by the contested candidate, Form No. 1B (on letter head) -Format of Chartered Accountant Export Certificate, Form No.-II- Withdrawal Form for the candidates of CoA and Election Rules are available on the Council's website at www.isepcindia.org and can also be downloaded, if desire. 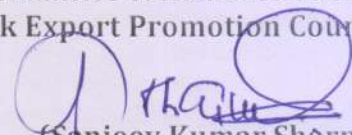
